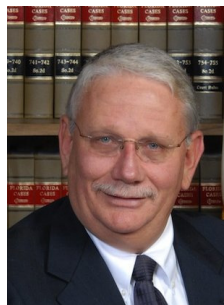

## Government Committee

Redistricting remains in the news. The Florida legislature approved their maps. The state Senate and House maps have been sent to the Attorney General who must petition the Florida Supreme Court within 15 days. By the Florida Constitution, the Court must approve the proposed redistricting plan. If they do not, the Legislature may submit another plan and if it is not approved, the Court is authorized to create and enact a reapportionment plan, which is legal and binding.

The congressional redistricting was approved and sent to Gov. Scott for signature, per the Constitution. The Democratic party has filed a lawsuit, as has a coalition including the LWVF, Common Cause Florida and La Raza and 4 individual plaintiffs are also filing suit.

**Capital Reports** discussions have continued. Any member is invited to join the discussion. Come with information on bills you have interest in. We are following the budget, redistricting, medical and property insurance, prison privatization, health care coverage - Medicaid. We also watch for requests for action from the LWVF to contact our legislators. Our next meeting will be announced when it is determined.

**Lunch with Leaders** for March will be on March 23 with Jeff Lytle, Editorial Page Editor of the Naples Daily News and host of NDN's Newsmakers. We will lunch in the Naples Daily News Community Room at 1100 Immokalee Road. Space is limited to twenty participants so please reserve with me as soon as you can. Jeff is excited to meet with us.

Please also continue to observe meetings of the Board of County Commissioners on

the 2nd and 4th Tuesdays on Channel 97 and the City Council on the 1st and 3rd Wednesdays on Channel 98.

We met with Dr. Todd Vedder, Chair of Pediatrics at NCH and Chairman of the Board for the Safe and Healthy Kids Coalition of Collier County along with the Coalition's Executive Director, Paula Di Grigoli. There are 40 agencies involved in the Coalition which has 501(c)3 status and is currently working under the leadership of the NCH Foundation but includes Physicians Regional Hospitals, Fire Chiefs, EMS, Public Health and more. Dr. Vedder described his motivation to "think outside the box" when confronted with the incidence of drowning deaths and suffocation deaths among small children in this community. Their work is data-driven so the third area of concern is the high incidence of childhood obesity. In view of Dr. Vedder's and Ms. DiGrigoli's enthusiasm and their dynamic and practical programs, we feel certain that the statistics will be modified in short order.

## Spotlight on...Vi Steffan

Vi Steffan can certainly be proud of being named a "Woman of Distinction" by the American Association of University Women. But she has many other extraordinary achievements she can point to such as being the Director of Operations in the Covert Action Department of the CIA where she "ran" a KGB agent who defected to the U.S. Her career began in the Department of Justice and advanced to Attorney General Ramsey's office, before she moved on to the CIA.

Since moving to Naples in 1995, Vi has served as President of AAUW (2008-2010) and is deeply involved in Greater Naples Leadership and Laces of Love as well as the League. These organizations necessitate lots of meetings, which she notes with a grin, can be a problem. "I don't know too many women with several outside activities who can attend all the meetings comfortably," she observed.

"The empowerment of women and girls is one of the issues that is most special to me." She acknowledges that equity for women and the passage of the Ledbetter Fair Pay Act have been among her favorite issues. *Reading Lolita in Tehran* is a book that she recommends reading two or three times in order to better understand the nuance of difficulties women experience in other countries.

With regard to the League, Vi says "I would like to see the League identify one or two specific areas of concern and make those issues the target of awareness programs to bring to the forefront of community attention."

Look for Vi at one of our luncheons - she has many stories to tell.

## Membership Committee

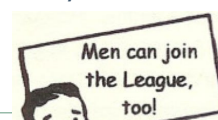

## News from the National League

In recent weeks the National League:

\* Applauded President Obama's move to deny the Keystone XL Pipeline. LWVUS President, Elisabeth MacNamara, called the step "a decision that puts the health and safety of Americans ahead of blind reliance on fossil fuels. The route of the Keystone XL Pipeline was a threat to the drinking water of millions of Americans. The pipeline was just too big a risk to allow it to go forward".

\* Reported that the League has surpassed its goal of 25,000 signatures on the petition to ask the White House to appoint new members to the Federal Elections Commission and help stem the tide of big money in campaigns. Leagues on the front lines in places like Florida, New Hampshire, South Carolina and Virginia are busy protecting voters. In Maine, Democrats and Republicans joined together to defeat legislative language that would have required photo ID at the polls.

\* Announced that registration for the Rio+20 Conference on Sustainable Development, "Rio+20", is open and will close on May 20. The conference, to be held in Rio de Janeiro, Brazil, June 20-22, 2012, will be preceded by the third Preparatory

Committee meeting of the Conference from June 13-15. All attendees must be registered by the League's UN Observer, Rosalee Keech.

\* Joined the Texas League in speaking out following the Supreme Court ruling regarding the state's controversial redistricting plans. The decision leaves the fate of the Texas redistricting plans and primary election schedule uncertain, and the San Antonio court has been ordered to develop another set of redistricting plans. The League has long advocated for a more fair and neutral redistricting system in the state. Meanwhile, the Pennsylvania League and a group of citizen plaintiffs are celebrating a historic victory as the state Supreme Court has struck down the state's overly partisan redistricting plans.

## News from the State League

Two of us represented LWVCC at the Legislative Summit in Tallahassee: Dr. Kathy Ryan and I were able to meet directly with Senator Garrett Richter and Representative Matt Hudson. Representative Kathleen Passidomo had other obligations during the Summit. When meeting with the two legislators, we presented each law maker with one-page issue sheets outlining those bills the League is particularly tracking:

- **Elections Bill** (SB 1596, HB 1461) regarding the resolution of a conflict in the state election law involving the use of voter's identification at the polls;
- **Energy** (SB 2094, HB 7117) which deals with energy conservation and renewable energy. The Collier County representatives urged both legislators to support an expansion of bills in the future by setting renewable energy targets, which are lacking in the current bills;
- **Ethics** (SB 552, HB 359) which prohibits legislators from voting upon, participating in or attempting to influence the passage of any legislation that would result in their enjoying any special private gain for themselves or their relatives;
- **Legislative Immunity** (HB 7213, no Senate companion bill), which created an "absolute privilege" for legislators, former legislators and legislative staff in certain legal actions or proceedings. This bill was abruptly dropped after Democratic legislators spoke out against it, and editorials and media pieces appeared against it.
- **Public Meetings** (SB 206, HB 355) which addressed the issue of members of the public having a reasonable opportunity to be heard before a board or commission. We urged the legislators to include specific guidelines for rules or policies for consistency purposes.

We learned of new bills that will negatively impact **women's health**-- specifically, Senate bill 290, an omnibus anti-abortion measure, which imposes a 24-hour waiting period before a woman can have an abortion, restricts ownership of abortion clinics to doctors who have specialized in abortion procedures during their residency, and requires doctors who perform abortions to take an annual ethics class. It will next be heard in the Senate Criminal Justice Committee. The House bill (HB 277) requires women to be told that fetuses can experience "fetal pain" during an abortion after 20 weeks in the womb (note: scientists are divided on whether this is true). The House bill will be heard by the full House next week. The League is urging members to contact the committee members and ask them to vote "NO" on SB 290.



As you may know, the League and others have filed lawsuits challenging the redistricting maps drawn by the legislature and oral arguments have been scheduled to be heard by the Florida Supreme Court.

Finally, we heard various legislators from both houses and of both parties describe what they do and what their own priorities are for the legislature. Ben Wilcox, the LWVF Governmental Consultant, was available for comments and advice on these and other issues. Overall, it was an interesting and educational experience that more of our membership should experience. Kathy Ryan and I strongly urge you to consider attending next year's Legislative Summit.
