### Raising Awareness of Human Trafficking in Southwest Florida

The Justice committee will present a panel of three outstanding women, who are making a difference in providing support, rescue, and rehabilitation for victims of human trafficking in Southwest Florida.

Linda Oberhaus has more than 25 years of professional experience in the human service field. She joined The Shelter for Abused Women & Children in 2007 as the Executive Director and previously served as the Executive Director for the certified domestic violence center in Tampa, Florida.

Marisol Schloendorn began her career with the Collier County Sheriff's Office in 2001 as an Investigator. In 2006, she was assigned to the human trafficking investigations unit. She coordinates basic human, psychological, and legal needs for victims of human trafficking.

Charlotte Newell is a graduate of the Jackson Institute for Global Affairs at Yale University with a concentration in International Security. Her interest in illicit markets was a clear segue into the human trafficking program at the Women's Foundation of Southwest Florida. Charlotte will serve as our moderator.

## Environmental Affairs Committee

Last month Burnett Oil Company, headquartered in Ft. Worth TX, received permission to begin their exploration for oil in Big Cypress National Preserve at the end of March. It began with an on-foot and small vehicle survey to identify routes for the next phase of the survey which involves data acquisition equipment; *Vibroseis Buggies*, each of which weighs 60,000 pounds.

Interested in knowing more about this? Wondering if our state legislators will pass a ban on fracking-like, acidizing techniques for gas and oil drilling this session? Fracking is one of the key issues we will be addressing at the next meeting of the Environmental Affairs Committee.

Other key legislative issues related to water quality are also on the agenda. In addition, there will be an update on the proposed Harvard University planning study of sea level rise in Collier County; it is now likely to come before the county commissioners this month. How should we adapt to the inevitable SLR? How can we mitigate the effects of climate change, such as SLR?

Expanding the use of solar energy is one way. Leagues throughout the state are making great strides in doing just this through the creation of solar co-ops. We will be joining this effort and plan to work in concert with the LWVF and [FLSUN](#) to launch a Collier County Solar Co-op. A steering committee is being formed to establish a launch date, market the effort and sign up

## News from the State League

**Charlotte Nycklemoe**

**Tell them to VOTE NO on HJR321 and SJR866.**

HJR321 and SJR866 are a blatant attempt to put lipstick on a pig in the name of protecting our sacred constitution.

These resolutions clearly squelch the voice of the people and make the one process citizens have as a last resort, after legislators refuse to listen to their constituents, to put issues before the public for a vote and to pass into law. To listen to yesterday's debate one would think that citizens are running amok with all sorts of crazy ideas for our constitution.

Fact: The legislature has put over 300 ballot measures before voters ranging from tax exemptions to obvious lobbyist interests. Some good, some bad.

Fact: Citizens have put thirty-six (36) ballot measures before voters; most recently:

- Fair Districts,
- Funding for Florida Land and Water and
- Class Size Restrictions.

The notion that it is too easy to change the constitution? Yes! It sure is if you are a legislator.

If you are a citizen? These are the hurdles:

- Within a two year time frame, citizens must work with legal counsel to write a single subject amendment.
- Citizens must get 65,000 signatures on a petition.
- Citizens must get the petition validated by the Supreme Court.
- Next the real work begins - collecting over 766,000 signatures.
- Then citizens must *pay* local Supervisor of Elections to verify that all signatures are legitimate voters.
- Finally, citizens must run a statewide campaign to educate voters on what the amendment will really do.

*Pocket change? Easy?* How about millions of dollars and almost impossible.

The numbers speak for themselves; citizens do this as a LAST RESORT, when legislators fail to listen to us.

If these resolutions move, rest assured that people will be informed. When Rep. Ingoglia states that "*The people's will is electing representatives to come up here to represent them...*", he got it a bit wrong. The *people elect representatives as public servants to express THEIR will*. Listening is a big part of the job. Remind your representatives that it is our will to have a voice.

## **News from the National League**

Last month the National League:

Urged Opposition of Election Assistance Commission Termination Act in a memo to members of the Committee on House Administration. At this time the League does not believe terminating the EAC is warranted and urges the Committee on House Administration not to report this legislation. LWVUS also joined a [coalition letter](#) sent to the committee opposing the termination of the EAC and the Presidential Election Campaign Fund.

Joined LWVMD and 40 other national and local organizations supporting rescission of a resolution that calls for an Article V Constitutional Convention. Under Article V of the U.S. Constitution, a convention can be called when two-thirds of the states (34) petition for a convention to enact amendments to the constitution. There are no safeguards or guidelines in the U.S. Constitution that limit a convention to one issue or govern the rules of a convention, which makes the threat of a runaway convention very real.

Joined women's groups on a letter opposing the repeal of the Affordable Care Act (ACA) and defunding Planned Parenthood. The letter went to the majority and minority leaders in the U.S House and Senate.

Sent an action alert to members calling the House plan to replace the ACA "un-American", stating that "The American Health Care Act will increase costs for seniors and those with pre-existing conditions while slashing assistance for lower- income households in obtaining coverage. It will also threaten the essential care that women need."

Called on the U.S. Senate to oppose the Regulations from the Executive in Need of Scrutiny (REINS) Act of 2017 and the Midnight Rules Relief Act. Under the REINS Act, no major regulation could take effect unless it is



approved by both houses of Congress in a small window of time, making it impossible to protect the public by shutting down the entire regulatory system including attacks on many consumer protection measures. The Midnight Rules Relief Act would enable Congress to repeal many regulations at once by packaging them in a single resolution that would get expedited consideration and require only a majority of votes for passage in the Senate.

Joined an amicus in *Maslenjak v. United States* to be argued at the U.S. Supreme Court on April 26, 2017. The brief argues that the Sixth Circuit Court's holding --- that any knowing false statement or omission can be grounds for denaturalization and criminal prosecution--- would have dire consequences for naturalized citizens, significantly discourage lawful immigrants from seeking citizenship, and undermine a cornerstone of American society and values.

Announced that National Convention 2018 will be held June 28 - July 1 in Chicago. State and local Leagues are encouraged to save the date and add a National Convention line item to their budgets for FY2017-18. Registration fee will be \$450/person; double rooms at the Hilton Chicago are \$209 plus tax per night.
