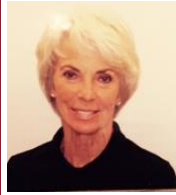

Linda Oberhaus, Director of the Shelter for Abused Women and Children, was the speaker for the February meeting. Her focus was human trafficking, including how the Shelter has served victims, the new Shelter to be built in Immokalee, and work with the Collier County Sheriff's Office unit dedicated to human trafficking. She noted that trafficking is a \$9 billion industry, second only to drug trafficking, and that a majority of confirmed victims are now found to have been born in the U.S.

The speaker for the March meeting will be Cynthia J. Prime, a Caribbean born social activist who has traveled throughout the United State, Canada and the Caribbean for over a decade, inspiring and motivating battered women and teen girls to get beyond suffering and survival to a fully empowered life. Ms. Prime is the CEO of Saving Orphans Through Healthcare and Outreach (SOHO) and is the author of *The Hope Seekers, Survival of Southern African Child Led Households in the Shadows of HIV/AIDS*.

We are looking forward to the unique opportunity to learn about international issues related to trafficking of women and children and welcome your attendance and that of your friends.

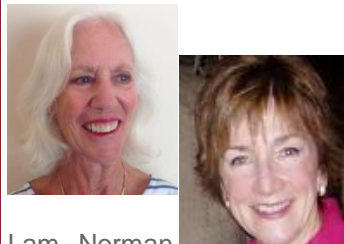

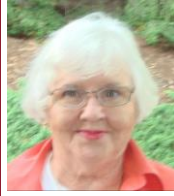

## News from the State League

**Charlotte Nycklemoe**

The Open Primaries Study is completed and has been sent out to League Presidents and members of the ad hoc Open Primary Study Team across the state.

Primaries first began in the early twentieth century as a response to increasingly strong party control over elections. At the time, voters wanted a larger say in who would be chosen as their candidate, instead of the long-standing tradition of party heads choosing who would run for office. Progressive reformers viewed direct primaries as a way for constituencies to increase transparency and allow for citizens to participate in the electoral process. As primaries became a feature of local, state, and eventually national elections, each municipality had the ability to shape their own process.

Today, most systems fall under two broad categories, Partisan and Nonpartisan primaries, with variations falling under each.

Open primaries allow voters to vote in the partisan ballot of their choice. This means that political parties cannot prevent non-members from voting in their party elections. Voters may select from the Republican or Democratic ballot.

After 22 months, the LWVFL Open Primary Study is completed and consensus meetings will be held across the state soon. If you are interested in knowing what's in the study, [please view and download it here.](#)

## News from the National League

**Ann Campbell**

Last month the National League:

Announced that the LWVUS Board has set legislative priorities for 2017: 1. Campaign for Making Democracy Work (MDW) with special emphasis on protecting voting rights. 2. Watchdog: Respond strategically on issues with LWV positions when needed, but focus on the campaign for making Democracy Work. Recognizing that the next year will be full of the unexpected, the board can re-examine or re-align legislative priorities as the situation may dictate. Advocacy staff, working with the president and advocacy chair, will respond to watchdog issues like the Affordable Care Act (ACA), immigration, and climate change as time allows.

Reported that League leaders are speaking out on redistricting challenges in Pennsylvania and North Carolina. With an eye on 2018, voter suppression and voter ID laws are hot topics for which League experts continue to provide analysis. A proposed new voter ID law in Iowa would be costly to taxpayers and the League is out front in pointing out the many problems with this legislation.

Joined a letter to members of Congress opposing efforts to overturn the Bureau of Land Management's Methane and Natural Gas Waste Rule under the Congressional Review Act (CRA). The BLM rule is a common sense policy that requires the oil and gas industry to reduce venting, flaring and leaks on public and tribal lands by deploying methane mitigating technology.
