If you are considering expanding the scope of your League involvement, do consider joining the education committee. The first meeting of the season was held on Nov 18. The next meeting will be Tuesday, Dec 16.

The committee will focus on the status of very early childhood education (VPK in Collier County) and what is needed to expand the numbers of children who start kindergarten with the skills necessary to succeed in school.

Members will also follow the lawsuit in which the LWVF is a participant, challenging the constitutionality of Florida's school voucher program, as well as current and future legislative efforts to expand the reach of this program and charter schools.

At our first meeting of the season on November 3, Government Committee members began learning about current issues being addressed at the county level. We learned about the recent activities of the Community and Human Services Department (formerly the Housing, Human and Veteran Services Department) and its key partnership groups. We also learned about the County's Community Redevelopment Agencies (CRAs), fortuitously providing us with background to Commissioner Fiala's remarks at the following week's LWVCC General Meeting about the project at U.S. 41 and Davis Blvd.

Between now and January, we will focus on Collier County government. Committee members have already identified county government efforts in the areas of human trafficking, business incubators/accelerators, the Clerk/BCC relationship, and the environment as topics for discussion, with more to come.

In February, we'll turn to the state Legislature, meeting every other week during the 60-day legislative session that begins in March.

The goals of the Government Committee include:

- Educating our members and the community about state and county government and important government issues.
- Researching and discussing pressing local, regional and state government issues to identify those that deserve further study, and then reporting these findings to the League Board and membership so that these issues may be considered for advocacy.

Our next three meetings will be on Mondays 12/1, 1/5, and 2/2, from 9:30 - 11:00 am.

The Justice Committee will work on the following two goals for the 2014-15 season.

1. Continue to observe Juvenile Court.
2. Identify and research safe harbors/facilities/programs for juveniles of Collier County.

At our last meeting Judge Christine Grieder informed us of her appointment by the Florida Supreme Court to a steering committee charged with four (4) objectives:

1. Implementation of a School Justice Partnership.
2. Examination of the statutes that impact the family court concept.
3. Monitoring progress of the "one judge/one family" model.
4. Assisting in developing a family court tool kit that addresses the developmental needs of youth, including children who experienced trauma.

We will monitor of the progress of this steering committee because its findings will ultimately be incorporated into our own committee's recommendations.

At our next meeting we will review the various programs and safe harbors for our at-risk juveniles.

Access to Mental Health Services: What is available and where to begin.

At our December 10 meeting we will talk about mental health services in the community with Margot Escott, LCSW, representing the Mental Health Association of Southwest Florida. We will gather at the Wilderness Country Club for a light lunch.

Margot is a clinical social worker and psychotherapist who has had extensive training in addiction studies and therapeutic humor. She works with PTSD, anxiety disorders and depression using techniques such as Mindfulness, Meditation and Visualization. She also works with caregivers for the chronically ill and elderly. So, while many of us think of mental health care in terms of a psychiatrist who will prescribe medications, I think that Margot will help us to look at the range of resources we can access to deal with the challenges we face in our lives.

News from the National League

In recent weeks the National League:

- Joined 1,200 leading national, state, tribal, and local organizations on a letter to Congressional leaders urging them to provide continued funding for the Children's Health Insurance Program (CHIP). Congressional action is needed in the lame duck session to ensure that states can continue to operate programs and provide health coverage for millions of children.
- Announced the formation of the **LWV Money in Politics Committee** as part of the 2014-16 League Program on Key Structures of Democracy. The Committee will conduct an update of the League's position on campaign finance for the purpose of addressing the lack of member understanding and agreement as to whether financing a political campaign is protected speech under the First Amendment. The campaign finance position will be updated through a study and consensus process.
- Formed a **LWV Constitutional Amendment Committee** as another focus on the Key Structures of Democracy. The committee will study the process by which the U.S. Constitution can be amended, including the constitutional convention method, and identifying the gaps and challenges in those methods.
- Noted, in LWVUS President Elisabeth Mcnamara's letter to members, that in the area of Immigration, the League believes that law enforcement resources should not be wasted on deporting law-abiding immigrants regardless of their legal status. She adds that we can make that position known in Washington and in our state and local communities as well. Prosecutorial discretion, as demonstrated in President Obama's executive order, offers the community an opportunity to shape sensible policies that reflect our values and promote the interests of justice.
