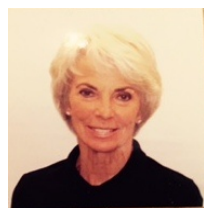

## League Policy Study

### Consensus Reached on Constitutional Amendment Study Questions

Over 30 LWVCC members actively and thoughtfully participated in our November 9 consensus meeting about the process of amending the U.S. Constitution and Article V Conventions. After a 30-minute background briefing, the group considered and reached consensus on 14 of 15 questions in a fast-paced discussion of each issue's pros and cons.

First, members came to consensus on five considerations for evaluating constitutional amendment proposals. Next, members agreed on seven conditions that should be in place for an Article V Constitutional Convention initiated by the states. Finally, members concluded that the League should consider supporting a Constitutional amendment that will advance a League position even if there are significant problems with the actual amendment as proposed, and even if it is being put forward by a procedural process the League would otherwise oppose.

Those who participated found the meeting very informative. Suggestions that we give reading assignments earlier and allow more time for discussion were much appreciated, and will be taken into consideration in planning the Money in Politics consensus meeting to be held in January.

A huge "thank you" to those who participated. You enabled the voice of the LWV of Collier County, Florida, to be heard as the National League frames its position on the Constitutional Amendment Process!

## Education Committee

Niccole Howard, the Executive Director of Collier Childcare Resources, Inc. (CCCR), was the guest speaker at the November 17 meeting of the LWVCC Education Committee. She presented information on CCCR and the challenges that her organization faces, as well as the challenges faced by the early childhood education industry as a whole.

CCCR is an organization that operates three child development centers: the NCEF Early Childhood Development Center on the south campus of FSW State College, and two Child Development centers at Golden Gate and Immokalee High Schools for teen parents. These schools receive significant funds from the Wine Festival; however, working families may still require additional subsidies to keep their children in the program.

The NCEF center offers service to a maximum of 110 children from infancy through four years of age. It partners with Able Academy to offer services to children with special needs. It has a 250 child waiting list.

CCCR also offers professional development programs for early childhood education teachers. There are roughly 100 early childhood development centers in our area, half of which are not certified and many of which do not offer a quality educational experience. Only 8% of the centers are accredited. These centers have more stringent staffing requirements primarily because the cost at these centers is over \$3000 annually.

Niccole listed the challenges that the entire industry faces:

1. A shortage of infant care centers. This is largely because this service requires one teacher for four children; the cost of hiring personnel renders these centers financially non-sustainable. Voluntary Pre-Kindergarten programs are more sustainable because many offer wrap around care to increase revenue.
2. Weak educational foundations. Some of the four-year-old programs stress rote memory rather than the development of social and problem solving skills. The quality of the education offered depends largely on the skill of the director.
3. Lack of parental engagement with the programs. This may be caused by the family's need to work long hours.
4. Lack of worthy wages for early childcare teachers. An increase in state funding would help to increase wages. The average salary for teachers with a 45 hour training program, is \$9.99 per hour. A credentialed teacher may make \$10 per hour. The state Office of Early Learning has control over wages. A couple of counties in Florida have county taxes that supplement better wages for early childhood programs.
5. Dual language families. This can be a problem when the parents are not educated and articulate in their native language. There is a movement to hire two teachers in a class: one speaking English and one speaking Spanish or Creole.

After further discussion it was determined that the role of the League is to educate the community about these challenges; to encourage access to quality early childhood education for all and to keep an eye on legislation at the state level that impacts services to children.

Myra Shapiro of the Naples Alliance for children will be our guest speaker at the December meeting. She will help us further our understanding of early childhood education and indicate what we can do to advocate for it in our community. All are invited!

Do you want to learn from fellow League members about your state and local government? Then the Government Committee is for you!

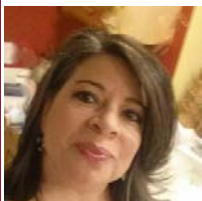

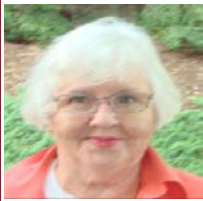
\*Members who joined April 1, 2015 or later do not need to renew, since their current memberships are valid through December 31, 2016.

### Follow-up on our November meeting about the School Nurse Program

We met with Debbie Stultz, RN, Director of the Collier County School Nurse Program to share our concerns about the new staffing model that reduces the number of Registered Nurses and adds Nursing Assistants. Working under the auspices of Naples Community Hospital (NCH) which has had the contract to provide the program since the beginning, Debbie has crafted a management plan that was reassuring to our group. There is a four week training accompanied by a comprehensive manual; nurses and assistants work in teams under a "Lead RN". Assignment of nurses and assistants is flexible according to the acuity of medical issues in each school. With 50K plus students in 58 schools we are still wondering how the nurses can spread their expertise around. A very positive note: Debbie tells us that they are collecting data on this first year pilot to include feedback from all stakeholders. We hope to receive the finished report.

## News from the State League

### Charlotte Nycklemoe

Campuses are generally safe places. Do we really want to turn them into just the opposite, when a student who has had too much to drink can pull a gun over an argument with a friend? When a gun accidentally goes off because it wasn't properly secured? When a student, who has no knowledge of how to handle weapon, picks up the gun of a roommate out of curiosity? When a depressed and suicidal student can turn to a gun on impulse and pull the trigger?

### Stop Campus Carry.

In an environment that encourages open discourse, what kind of effect will guns on campus have on the freedom of students to debate, to passionately disagree? If a student knows those around him may be carrying a concealed weapon, will he feel as comfortable voicing his opinion? And what about the angry student confronting a professor over a grade? Many instructors will tell you that such confrontations can escalate quickly. Do we really want to add a gun into that mix?

### Stop Campus Carry.

The gun lobby argues that allowing permit holders to carry concealed weapons will make college and university campuses safer. But the facts don't bear that out. Young adults between the ages of 18-25 experience the highest rates of mental illness. Suicide is the second leading cause of death among college-aged students.

The gun lobby argues that women need firearms to protect themselves on campus. Again, the facts don't bear that out. Most campus sexual assaults occur among people who know each other, who may trust one another. Between 80-90% of such assaults involved acquaintances, not strangers. That limits the possibility a victim would be carrying a gun during an attack. And arming the victim doesn't rule out that the assailant may also be armed.

Law enforcement officers undergo weeks, months and years of training. Your average concealed permit holder does not. In addition, when police arrive on the scene of an "active shooting," just how are they supposed to tell the "good guy" from the "bad guy?"

### Stop Campus Carry.

Protect our students, faculty, college administrators, and visitors to campus. As the saying goes, the college years can be the best of one's life. Let's not change that by introducing firearms onto campuses by those who have neither the experience nor proper training to use them. Let's allow the police to do their jobs.

## News from the National League

### Ann Campbell

In recent weeks the National League:

- Announced that Money in Politics background papers have been posted. Hard, Soft and Dark Money presents ways that outside groups try to influence elections through hard money, soft money and dark money, and Options to Reform Money in Politics covers campaign finance reform strategies that are currently allowable in the wake of Supreme Court decisions. The official MIP Consensus form is also posted for Leagues to use to report their consensus reports. All these materials can be found on the Money in Politics page. To learn how other Leagues are conducting their consensus meetings, join the discussion in the [MIP Google Group](#).
- Reported that the League has been working from several fronts to stop resolutions of disapproval in the U.S. House and Senate that would block the Clean Power Plan. LWVUS joined a letter from environmental groups that went to the Senate on the eve of votes taken on the resolution. Legislation in the Senate passed on November 17 and it now moves to the U.S. House. League members and supporters should take action by contacting their members of Congress urging them to oppose this legislation.
- Called the defeat of the XL Pipeline a major victory for the health and welfare of the American people and our planet after the Obama Administration issued a full rejection of the permits necessary to build the Keystone XL (KXL) pipeline. This is a major victory for the League, environmental groups and pipeline fighters around the country.
- Joined an amicus brief filed by the Leadership Conference on Civil Rights, the Southern Poverty Law Center and sixteen other organizations concerned about civil rights and equal access to education in the rehearing of Fisher v. University of Texas at Austin, a reconsideration of an identical case the Court heard just two years ago. The brief supports the University of Texas admissions policy as necessary in order for students to receive the vast and critical benefits associated with diverse campus environments. The LWV has a long standing position in support of access to public education that provides equal opportunity for all. We have fought since our inception to ensure that every citizen can fully and productively participate in American society, from the school room to the ballot box.
- Invited members to participate in the sixtieth session of the Commission on the Status of Women, to be held from March 14-24, 2016 at the United Nations Headquarters in New York. The priority theme is "Women's empowerment and its link to sustainable development".
