LEAGUE TAKES AIM AT PARTISAN REDISTRICTING

Washington, DC – January 12, 2006 As a part of its Democracy Agenda, the League of Women Voters has called on the U.S. Supreme Court to overturn the partisan gerrymander imposed on the citizens of Texas in 2003.

In an amicus curiae, or “friend of the court” brief the League of Women Voters of the United States and the League of Women Voters of Texas argue that the Texas legislature’s mid-census redistricting was unconstitutional because it was carried out solely to achieve partisan advantage. The law firm of Wilmer, Cutler, Pickering, Hale and Dorr LLP prepared the brief on behalf of the League. The Court will hear arguments in the case, *LULAC v. Perry*, on March 1, 2006.

“Partisan gerrymandering undermines the basic principles of representative government,” according to Kay J. Maxwell, president of the national League. “The Texas League fought this plan when it was presented, and we are proud to join with them in asking the Court to overturn it. Partisan gerrymandering subverts the democratic system because it allows politicians to choose their voters, rather than vice versa. This turns representative government upside-down,” Maxwell said.

The Texas mid-census redistricting case involves the threshold decision of whether to redistrict *at all* and not just a decision about how to draw the lines in a redistricting plan. While acknowledging that redistricting policy necessarily has an effect on election outcomes, the League in its brief urges the Court to decide that “there is a stark difference in kind between, on the one hand, relying on neutral considerations that incidentally affect partisan outcomes and, on the other, adopting exclusively partisan criteria for which specific partisan outcomes are the *goal*.”

By filing this brief the League of Women Voters continues its long history of fighting against attacks on the basic constitutional right to fair and equal representation guaranteed to all citizens by the Constitution. Leagues have worked vigorously across the country to secure representative redistricting plans in their states after each census and are seeking reforms to assure that the redistricting process is nonpartisan, equitable and open. These are core rights for citizens of a free and democratic nation.

The League’s Democracy Agenda is an advocacy and public education program to strengthen and renew the basic tenets of American democracy. This effort seeks to protect our electoral processes through election reform and campaign finance reform, advance our representative government through nonpartisan redistricting, and preserve our constitutional rights by safeguarding civil liberties.

VOTER SERVICE

Our Naples City Council Candidates Forum was held on January 19. My thanks to all the members who assisted at this forum as greeters, time keepers, question checkers and other important roles.

Know Your County Government, a teen citizenship program under the leadership of LWVCC, CCPS Social Studies Departments and Collier County Extension/4-H Youth Development will be February 23 through March 14. The program for 35 high school students exposes them to the purpose and function of county government, how it operates and what career opportunities it offers. Their on-site visits include the Health Department, Sheriff’s Department, Animal Control, Tax Collector, Supervisor of Elections, a water treatment plant, the county landfill to name a few. The students also have the opportunity to interact with the constitutional officers, county commissioners, county manager and a school board member to list a few.

Opposed the Reauthorization of the USA PATRIOT Act

The League of Women Voters opposes the conference report on the reauthorization of the USA PATRIOT Act. While the House of Representatives passed the conference report on December 14, the Senate failed to follow suit. Several days later, a Senate vote to stop a threatened filibuster failed, 53-47, falling short of the 60 votes needed. We must stop the reauthorization in the Senate.

Opposed Torture; Support the McCain Amendment

Earlier this month, the League issued an [Action Alert](#) urging members of Congress to support the amendment opposing torture, sponsored by Senator John McCain (R AZ), in the Department of Defense Appropriations bill.

President Maxwell Speaks at Presidential Public Financing Conference

At a conference on Capitol Hill sponsored by the Campaign Legal Center and Democracy 21, LWVUS President Kay J. Maxwell spoke on a panel about "The Issue of Presidential Public Financing: Its Goals, History, Current Status and Problems."

Bill of Rights Day

December 15 was Bill of Rights Day. The LWVUS put out a press release urging the protection of civil liberties in honor of this day.

HOMELAND SECURITY IN COLLIER COUNTY

The study committee met with Dr. Judith Kolva, Assistant Professor at International College to review the activities of her interdisciplinary students' project on Homeland Security in Southwest Florida. While they focused only on terrorism, we are looking forward to reading their case study when it is available.

In the meantime, a meeting with Dan Summers, Emergency Operations Director, is scheduled for January 23, 2006 at 8:30 am. The purpose is to gain insight into the County's hurricane planning---one aspect of homeland security. OUR LEAGUE IN ACTION

January 12 – Sheilah Crowley presented testimony to the Metropolitan Planning Organization on the Long Range Transportation Plan on our position for energy-efficient and environmentally sound transportation systems (see page 8).

January 17 – Sue Bookbinder, Sandy Parker and Chris Straton met with Representative Mike Davis (District 101) to encourage him to sponsor the Equal Rights Amendment in the upcoming Legislative Session. Also helping develop the presentation were Sally Lam, Cecile Rivel and Nancy White. LWVCC told Rep. Davis: "We believe that only a constitutional amendment can guarantee that all constitutional rights are held equally by all citizens regardless of gender, just as the 14th Amendment was necessary to ensure equal protection regardless of race.

January 18– Chris Straton and Sheilah Crowley met with Representative Mike Davis for the 2006 Legislative interview, asking questions from the LWV of Florida to help with lobbying in the coming legislative session.

January 19 – LWVCC hosted a Forum for candidates for the Naples City Council. Sandra Brown organized the forum, Kathleen Slebodnik moderated, and many members assisted that evening.

LWVCC NON PARTISAN POLICY

Preamble

The purpose of the League of Women Voters is to promote political responsibility through informed and active participation of citizens in government. The LWV is nonpartisan in that it does not support or oppose any political party or candidate; it is political in that it takes positions on selected governmental issues after member study and agreement.

The League recognizes the role of the political parties in our form of government and believes that participation in the activities of the political parties is an essential ingredient of citizen responsibility. While the League urges its members to be politically active, certain constraints are necessary in order to maintain the nonpartisanship of the organization. The Board of Directors of the League of Women Voters of Collier County has established the following guidelines.

General Policies

1. All statements made in the name of the League shall be cleared through the President or the President's designated representative(s).
2. League members (non-Board) are encouraged to run for office and participate actively in the party of their choice.
3. Discussion of candidates shall be avoided at all League meetings except in connection with Voter Service discussion of all candidates.
4. Other than invited speakers, no one may distribute materials at a League meeting without prior approval of the President. Campaigning politicians or their representatives cannot campaign or distribute campaign literature in League meetings.
5. Only petitions approved by the Board may be circulated at League meetings.
6. Once League (local, state or national) takes a position on an issue, members may not identify themselves as League members when publicly expressing an opinion that is in opposition to a League position.
7. Members representing the League in the community should be sensitive to their responsibilities. When acting in the public as League representatives, members must not allow partisanship to be discernable. These members should be fully aware of League positions.
8. Members may serve on governmental committees at their own discretion. If the appointment is League-related, the appointee should be fully aware of the League positions as they relate to the committee's responsibilities.
9. Members in the leadership roles at committee and other public meetings have the responsibility to ensure the nonpartisanship of the meeting and its environment.
10. The membership directory shall not be used by members for other than League business.
11. To avoid misunderstanding, if a situation is not clearly defined and regulated under this policy, a League member shall seek Board advice.

Board Members

1. The Board has the responsibility of maintaining the fact of the nonpartisanship of the organization.
2. If a Board member plans to engage in political activity, that member must seek a Board decision as to whether the activity would affect the community's perception of the League's nonpartisanship.

Nonpartisan Policy, cont.

3. The President and Voter Service Director may not take an active, visible role in a campaign for a political candidate or for a non-League issue.
4. A Board member shall resign from the Board before publicly declaring candidacy for elective office.
5. During his/her term of office, a Board member **MUST NOT** give/sponsor candidate coffees or other fundraising parties or events; permit his/her name to appear in any media endorsement ad; hand out or display campaign literature; act as campaign manager or treasurer for a candidate; or hold office in a political party.
6. A Board Member other than the President and Voter Service Director may make financial contributions to political parties and candidates in national (other than the U.S. House of Representatives) and statewide elections.
7. A Board member **MAY**:
 - a. Attend political meetings, but keep a low profile.
 - b. Accept appointments to Advisory Boards.
 - c. Participate or hold office in other community organizations, as long as those organizations do not actively promote candidates. It must be clarified whether she/he is serving as an individual or as a representative of the League. If participating as a League representative, she/he will be expected to adhere to established LWV positions, if applicable.
 - d. Express publicly through letters to the editor, etc. personal views on non-League issues.
8. The political activities of a spouse or relative of a Board member are to be considered as separate and distinct from the activities of the Board member.

This nonpartisan political policy applies to all elections - partisan and nonpartisan.

GOVERNMENT COMMITTEE MONITORING ACTIONS

The Government Committee has monitored Collier County Board of County Commission meetings, Collier County Planning Commission meetings and the Metropolitan Planning Organization meeting. We wear our large League buttons and observe the meetings. We monitor these meetings to ensure that good government principles are being followed. We brought to the attention of the Planning Commission that there was an error in one of the Public Notices which, if uncorrected, would have resulted in failure to hold a legal meeting.

All indications from elected officials, appointed officials and members of staff are that they are glad to see that the League is involved and participating. If you would like to become a member of the Observer Corps, please contact Chris Straton. You don't need to be there for an entire meeting but it is important that we show up.

Long Range Transportation Plan (LRTP)

League members were treated to the opportunity to learn first hand about the transportation plans for Collier County. We learned about the proposed I-75 bypass, a brand new interchange on I-75, and extensions of various roads to address the expansion east of Collier Blvd., to name just a few. Details of the plan can be accessed at <http://collierlrtp.net/> In answer to a question about the relationship between land use and transportation; we learned that there is an effort underway to analyze Collier County at build-out and its transportation needs. We plan to bring the responsible persons to a meeting with the League.

On January 12, 2006 President Crowley presented testimony to the Metropolitan Planning Organization on the Long Range Transportation Plan. Her remarks follow:

"The League members thank you for your public service to the betterment of our community. We appreciate the opportunity to provide testimony.

The League of Women Voters of Collier County has been a voice for good government in Collier County for 31 years. Our position states, "energy-efficient and environmentally sound transportation systems should afford better access to housing and jobs..." We encourage the foresight provided by the plan presented this evening and urge the Collier County Metropolitan Planning Organization to continue to plan for the improved quality of life for our entire county and consider the greater good as opposed to the NIMBY (Not In My Back Yard) special interest groups. The League supports governmental action that results in meeting the needs of the present without endangering the ability of future generations to meet their own needs."

LWVCC Website Redesign Is Underway

In November, LWVCC members Ann Bleakley, Sandy Parker, Jennifer Walker and Trudy Weisberg formed a committee to redesign and update the LWVCC website, which is currently at www.naples.net/presents/lwvcc. Our new website will be well-designed and user-friendly, thanks to templates developed by LWVUS.

At its January meeting, the LWVCC Board approved the committee's proposed website content and the Request for Proposal they developed to solicit bids from four Naples-based firms to implement the new website. After evaluating the bids and interviewing the candidates, the committee will make a recommendation to the Board at its February meeting. The committee's goal is to complete the transition in the spring.

Online Roster: One of the many advantages of the new website is that members will be able to update their contact information (address, phone number, and email address) online through a password-protected portion of the website. Members will also be able to access each other's contact information in this online Roster, in the same way they look up this information in their paper Rosters today. Members who would prefer not to be listed in the online roster should notify Sandy Parker before March 31st.

MENTAL HEALTH SERVICES TOPIC OF JANUARY SOCIAL POLICY COMMITTEE MEETING

Don Williams, Ph.D., a retired clinical psychologist and program director for the Mental Health Association of Southwest Florida (MHA), had the rapt attention of the members as he talked about mental health services in Collier County. MHA, begun in Collier in 1957, partners with 22 of the 27 United Way Agencies. MHA is one of two mental health advocacy organizations in the county; the other is the local chapter of the National Alliance for the Mentally Ill (NAMI). While there is some overlap of services, according to Don, the two agencies work well together and have separate missions. MHA's mission is *to advocate for mental wellness through education, prevention and support*; NAMI is a *self-help, support, and advocacy organization of consumers, families and friends of people with severe mental illnesses*. Don says that both agencies advocate for the same legislation, i.e., Medicaid and Medicare reform, and provide outreach services for those with limited income.

When we first contacted Don, we asked him about community response to the hurricane-related mental health problems of our citizens. During the 2004 hurricane season that saw people from other areas seeking shelter in Collier County, MHA had an on-call group of mental health providers including psychiatrists, psychologists and social workers. As of the 2005 season, the Health Department contracted with the David Lawrence Center for services. Don noted that the mental health effects of the hurricanes often come later, after the excitement has died down. He went on to describe the many services of MHA: support groups, free referral to "every agency in Collier", education programs, and counseling programs. Since there are no licensed mental health professionals on staff, MHA cannot provide medical services but can refer clients to physicians for prescriptions and then refer them to NAMI where "stabilization meds" can be provided. Catholic Charities' counseling center also helps with medications for individuals who cannot afford to pay for them.

Don discussed other issues related to mental health including the financial implications of sharing one's residence with a mentally ill individual, the national problem of the mentally ill in jails and prisons and the need for legislation and funding to keep people out of psychiatric institutions AND jail. Mental illness is truly one of our nation's major health problems. MHA says that one in four families is in need of mental health services. DELINQUENCY PREVENTION AND ENFORCEMENT

On January 9, the Justice Committee was fortunate to have as its speaker Commander Beth Jones of the Collier County Sheriff's Office (CCSO). Commander Jones, head of the new Delinquency Prevention & Enforcement Bureau, provided a comprehensive overview of the Bureau. While she explained the various programs under Enforcement and Prevention, including the Weekend Consequence Program, one-day D.R.I.L.L., S.H.O.C.A.P, and the Truancy/Run-away service, the committee was most interested in the newest focus of the bureau - Services/Mental Health.

Commander Jones advised that the overall goal of Services/Mental Health is "... early identification of 'at risk' youth and family education and intervention." The youth (ages 8-18) are referred by family, school staff or other community agencies and don't have to be involved in the Juvenile Justice System in order to receive intensive services. As part of Services/Mental Health, the Sheriff's office has identified a new assessment tool to be given to all juvenile offenders. The Positive Achievement Change Tool (PACT), based upon the Washington State Juvenile Court Assessment, is going to be implemented statewide. According to Jones, "The assessment tools will help identify the risk of recidivism, future criminal behavior factors and identify appropriate treatment based upon High, Moderate or Low risk profiles." Following the assessment, treatment plans will be developed which direct the youth into services provided by the CCSO Delinquency Prevention and Enforcement Bureau or by community partners. Parent counseling, parent and community education, and follow up services will be important components of the intervention provided. Jones shared that the overall goal of education is to reduce juvenile crime and recidivism.

The committee also learned about Florida native Beth Jones' 16-year career in law enforcement. Given her experience as a parent, as a YRD (Youth Relations Deputy), DARE officer, and, most recently, Commander of D.R.I.L.L., she seems well positioned to head up the new bureau. It was clear that Commander Jones has a commitment to mentoring and guiding youth, and the committee looks forward to monitoring the accomplishments of the new bureau.
