

HAMILTON HARBOR – YES OR NO

On Tuesday, January 21, 2003, at 8:30 a.m., the Naples City Council will have the first reading on Collier Enterprises' most current plan for the Hamilton Harbor marina development. The development is proposed for the east side of Naples Bay adjacent to Bayview Park.

Efforts to develop this piece of waterfront property have gone through various manifestations in the past several years. Initially, the former Naples City Council voted to approve a larger Hamilton Harbor project in 1999. After several lawsuits were filed against the city, in response to the proposal, City Council reversed this decision in 2000. At that point, Collier Enterprises filed legal challenges against the city. In 2002, a new Naples City Council voted to settle with Collier Enterprises without court hearings. Collier Enterprises offered a less intensive plan.

In 2003, City Council will again be voting on a new plan

New Wetland Guidelines Unveiled

Our nation's wetlands are one of our most precious resources, but they are in constant danger of destruction. Since the late 1700's, we have lost over half of the nation's wetlands to development and other related activities. Closer to home, Collier County continues to lose significant wetland acreage each year due to development. Currently, three projects in northern Collier County are awaiting Army Corps of Engineers (Corps) permits to destroy more than 1,300 acres of wetlands. All this is happening, despite the federal Administration's goal of no net loss of wetlands and the Corps' policy of looking at avoidance of wetland impacts as the preferred alternative when developers seek permits.

In 2001, the National Academy of Sciences and the General Accounting Office released a report concluding, "that, despite progress in the last 20 years, the goal of no net loss of wetlands is currently not being met." In response, the government sent out a press release on December 26, 2002 announcing new guidelines for achieving wetland protection and no net loss. These new guidelines are designed to enhance the coordination efforts between the Corps and the U.S. Environmental Protection Agency, Department of Agriculture, Department of Commerce, Department of the Interior and Department of Transportation.

The new guidelines look at mitigation of wetland loss from a watershed perspective. Therefore, if a developer cannot avoid impacting wetlands, then mitigation within the project's watershed is emphasized and the needs of the entire watershed are considered when projects are permitted. Also, the guidelines focus on looking at wetland function for determining mitigation acreage, instead of automatically having a one-acre mitigation for one-acre destroyed approach. For example, if five acres of pristine wetlands are destroyed, then it may be determined that twenty acres of wetlands need to be saved elsewhere, due to the value of the wetlands destroyed. In addition, the guidelines highlight better consultation between government agencies, better accountability and monitoring of mitigation, enhancing public access to information, subjecting government projects (for example, highways) to the same set of mitigation rules that apply to private developments, and providing better information to those seeking wetland permits.

Though the government believes these new guide-

lines will increase compliance with no net loss, some environmental groups remain skeptical. One complaint is that because these are guidelines, they are not binding. In addition, there are concerns that vagueness in the guidelines will allow developers too much leeway. For more information on these new guidelines, check the web at www.epa.gov/owow/wetlands/.

In 2003, City Council will again be voting on a new plan for a marina. It was moved forward by the Planning Advisory Commission in late December 2002 despite objections from citizens and environmental groups. Members of the Marine Services Industry spoke in support of the project.

Supporters of a Hamilton Harbor marina feel there are benefits due to additional boat storage space (Collier Enterprises proposes 36 wet slips and 325 dry slips), and a fueling facility (which will be open to the public). There is considerable concern that if not approved the City will face legal action from Collier. Recent court decisions in similar land use cases decided by the Florida courts make outcome of such a case uncertain.

Opponents (including The Conservancy of Southwest Florida and Citizens to Preserve Naples Bay) believe that the project violates the city's Comprehensive Land Use Plan and its Development Code, which state that development is not permitted in the mangrove tidal swamp zoned as Conservation. Hamilton Harbor would dredge about 0.9 acres of this habitat.

Opponents also believe the petitioner has not demonstrated that it will be in compliance with the city's Marina Siting Criteria. In addition, these groups are not satisfied that Collier Enterprises has demonstrated that this project has addressed water quality issues or that the proposed marina is in the public interest.

The League Natural Resources and government policies support opposition to the project as it is currently proposed because it will result in the removal of protected resources and because the City's governing body is required to make land use decisions in compliance with its "Comp." Plan and its Development Code.

Reliable sources believe Mayor MacKenzie favors approving the project. Representatives of LWVCC have not spoken with the mayor or City Council members.

You can attend the public hearing on January 21, or watch on Channel 12. LWVCC will be prepared to issue a statement at the hearing. Members are encouraged to express their individual opinions at the public hearing and by writing letters to the editor.

The City Council will not take a final vote on the marina until the second public hearing, which will likely be in February.

LWVCC SPEAKS IN SUPPORT OF HUMAN RELATIONS BOARD

The issue drew a record-breaking crowd to County Commission Chambers. Supporters for a Human Relations Board were about equal to those in opposition.

Most of the people speaking in opposition to the new Board opposed its formation on religious grounds. The ordinance as prepared by Assistant County Attorney Robinson outlined particular reasons that were unacceptable bases for discrimination. Along with race, religion, gender, handicap and other minority categories, the ordinance included "sexual orientation." Some members of Christian organizations view homosexuality as a sin and for this reason voiced strong opposition to any sort of Human Relations body.

The League, under long-held positions on Civil Rights, supported the ordinance in its entirety.

LWVUS Starting an ERA Discussion Group

Information from LWVUS Post Board Summary
October 2002 - Received December 14, 2002:

LWVUS has approved the start of an on-line discussion group for the ERA. In computer terms, this is "an ERA-related pilot listserv." It will be given a six-month trial period. It is for individual discussion only and not meant to convey LWV position. Its purpose is "to allow interested members an opportunity to research and exchange information on the Equal Rights Amendment."

Its announcement comes with the reminder, **"Only the appropriate level of League board may take action or speak on behalf of the League."**
