Judges and amendments - Get ready for the November 8 General Election

Have you been confused by how, when and why we select, elect or vote to retain judges? And why is it so hard to learn about them before we vote?

Judge Joseph G. Foster, a Circuit Court Judge elected to the Bench of the 20th Circuit in 2012, will explain the process and answer our questions. He has been in Florida for 16 years and has practiced Law in both Ohio and Florida. He is a graduate of the University of Michigan and Case Western Reserve Law School, *cum laude*. He is actively involved in our community and has been honored by a number of organizations.

We will also briefly review the 4 amendments to appear on the ballot and what it will mean if we pass or reject them.

Tallahassee, Fla.- Sept. 26 - The League of Women Voters of Florida is pleased to announce the appointment of Anna Eskamani to our State Board of Directors." Anna brings a millennial mind and a profound history of accomplishment to our Board. We are thrilled to add her to our team of distinguished professionals who volunteer their time and talents on a daily basis encouraging strong nonpartisan civic education and engagement in Florida," said Pamela Goodman, LWVF President.

Anna is not afraid of change, she leads it. The Senior Director of Public Affairs and Communications for Planned Parenthood of Southwest and Central Florida, she manages the nonprofit's public affairs, field, and communications work through its 22 counties. An Orlando native, Anna's parents are both from different parts of Iran but found each other - and love - in the Sunshine State. Anna attended Orange County Public Schools and then the University of Central Florida (UCF), where she obtained two bachelor degrees, two master degrees, two certificates, and is now pursuing her PhD in Public Administration. In addition to her work at Planned Parenthood, Anna is an adjunct professor at UCF, a frequent guest contributor to numerous publications and serves on several nonprofit and advocacy boards. Anna identifies as a feminist, and is committed to building collective power within her community and throughout the state. When she is not traveling across the state and working from her car, Anna loves to read, spend time with family and friends, run, and visit Florida's state parks. She has been a longtime member of the League of Women Voters, first becoming a member at age 20 and working with then President Deirdre Macnab to establish a reduced membership rate for students. She then served as a board member for the Orange County League of Women Voters for 3 years.

News from the National League

Ann Campbell

Over the summer the National League:

Held its 52nd national convention in Washington, DC, in June, at which a new president, Chris Carson, and board were elected, a budget adopted and planning begun for the national program - the campaign for Making Democracy Work. " That means accelerating the pace of change within the League and having a bias toward action, taking advantage of alternative engagement opportunities, focusing our agenda, and wrestling with the tough questions of whether our current structure and approaches reflect a 21st century organization." (Chris Carson)

Asked League members to lobby their members of congress on legislation that would repair the Voting Rights Act to its full powers. This legislation, the [Voting Rights Amendment Act](#) will level the playing field and ensure that all Americans have fair and equal access to the voting booth

Announced that the League will partner with the [United Nations on Alliance 8.7](#) in an effort to bring an end to Human Trafficking which, along with forced labor, affects 21 million people all over the world including here in the United States.

Joined partners on a [letter to the U.S. House opposing H.R. 5053](#), legislation that would eliminate the requirement for 501(c) groups to disclose their donors to the IRS.

Sent [comments to the U.S. Census Bureau](#) regarding the decision to continue using the "usual residence" rule. The rule counts incarcerated citizens at their prison addresses rather than their home address. The League believes that the Bureau's decision undermines the redistricting process in states across the country by distorting state and federal legislative districts. This upsets the balance of power and disproportionately under represents minority populations in communities across the country.

Joined the Election Protection Coalition and its member groups on an [open letter](#) to the Democratic, Republican, Green and Libertarian parties. The letter addresses political calls for increased presence of law enforcement officials and election observers at polling places in November. The League and others believe that a continued call for protection against voter fraud will dissuade voters, especially communities of color, from participating on Election Day.

Filed an Amicus Brief in *A. Philip Randolph Inst. v. Husted*, joining Project Vote and Common Cause in 6th Circuit Appeals Court. The brief argues that methods used by the state of Ohio to remove voters based on their voting status from the voting rolls should be prohibited. Purging voters from the rolls because they didn't vote in previous elections creates confusion for voters and is in direct violation of the National Voter Registration Act (NVRA) and the Help America Vote Act (HAVA).
